



Better Bicycling Grants

Since 2017, LMB has grated nearly \$150,000.

LMB has supported nearly 50 organizations and municipalities across the state who are improving access to bicycling.

In 2022, thanks to the generosity of donors, we were able to offer two rounds of grants.

This year we rebranded from Micro-Grants to better represent amount of funds given away.

Fall round currently open (deadline Nov. 8), grants of \$500 to \$2,500

Previous Grant Awardees



Vivela (Southwestern Lower Peninsula)

this bike club, whose slogan is "mas Latinos on bikes" used a grant to introduce new bicyclists to fat tire and winter bike riding



Munising Bay Trail Network (Upper Peninsula)

Purchased a bike trailer for hauling trail repair equipment to remote parts of trails



Muskegon Area Bike Library (Western Lower Peninsula)

Used funds to purchase 60 child and adults bikes in partnership with a local library who lends the bikes to the public

MI Cycling Census - Preliminary Data

Conducting a survey open to all cyclists in Michigan to determine largest areas of need for policy action, look for trends in types of bicycling, and learn more re: what kinds of events cyclists want to participate in.

Biggest takeaways are what we already know:

- Mostly males (63%)
- Caucasian (89%)
- Income over \$100k (44%)
- Over age 55 (64%) From southeast MI (41%)

Other interesting facts

- 42% have been in a crash (36% involved vehicle) 70% NOT reported to the authorities
- Reason for cycling: "For exercise" top response
- What motivates you to ride more: "Improved health"

Barriers to riding:

- Aggressive drivers
- Poor infrastructure (though some ride because they have bike lanes)




Call to Action: Michigan Cycling Census

- Takes 5-10 mins
- 2000+ responses thus far
- Goal 5000+ (bigger/more diverse data set)

Law Enforcement Training

Focus has shifted from training currently licensed (in-service) police officers
Trained 100 police recruits at 3 academies in 2023
We have 5 academies on board for 2024

Will continue to work on training in-service officers as requested

"C3Feet" measures passing distance of vehicle

Plans for video on how to use and deploy the device for enforcement and education in 2024

Training for Citizens

Bicycle Friendly Driver

The Bicycle Friendly Driver program is a 1 hour online self-paced class, aimed at educating drivers on the best practices to share the road with people on bicycles.

- What's legal and not legal, for both motorists and bicyclists
- Common crashes and how to avoid them
- Why bicyclists "take the lane" and what motorists should do in response
- How to navigate bicycle related infrastructure such as: sharrows, bike boxes, and green lanes.




Grant Flexibility in Setting Safer Speed Limits

Support HB 4012 (Slagh). Corrects a flaw in current law, which requires many speed limits to be set too high. Allows communities to potentially lower speed limits further when hazards to public safety are present. On Oct. 12, passed the House 100-10.







Create Incentives for E-Bike Purchases

Support HB 4491 (Rogers). Incentives can make e-bikes accessible to the people who benefit most from lower transportation costs. Provides an incentive of \$500 for all e-bike purchasers, with an additional \$750 for low-income households.



Include E-Bikes as Transportation in Clean Fuel Standard

Support SB 275 (Singh) if amended to include e-bikes. The bill would establish a clean fuel standard that will decrease the carbon intensity of fuels in Michigan by 25% by 2035. The target applies to the entire value chain of transportation fuels. LMB supports this bill if it is amended to specifically include electric bicycles.



Establish a New Mobility Asset Management Council

Bill to be introduced. Establish the New Mobility Asset Management Council (NMAMC) within the Michigan Infrastructure Council, extending TAMC model to non-motorized and motorized recreational trails, Electric Vehicle charging stations, clean alternative fuels stations, on-road bicycle lanes, sidewalks, side paths, micromobility stations, aeromobility, and V2X infrastructure.



Enact Legislation to Protect Vulnerable Roadway Users

Bills to be introduced (Sen. Sean McCann or Rep. Julie Rogers). Create enhanced penalties for drivers who injure or kill a vulnerable roadway user (VRU), including people who bike, walk, or use wheelchairs. "Given the current state of Michigan law, when a motorist injures or kills a bicyclist, the prosecutor is left with an almost impossible decision regarding the appropriate charge for the crime and it is damn near impossible to obtain a meaningful conviction."

Support Efforts to Reform No-Fault

Support SB 530 and SB 531, which would reform care for individuals who are catastrophically injured in car crashes, including bicyclists. Drivers kill more than 20 bicyclists and seriously injure more than 125 more in Michigan crashes each year. Each of these seriously injured people will require significant rehabilitative care to resume the normal activities of their daily lives.



Dear Chair Cavanagh, Vice-Chair Moss, Minority Vice-Chair Huizenga, and members of the Senate Finance, Insurance, and Consumer Protection Committee:

The League of Michigan Bicyclists supports SB 530 and SB 531, which would reform care for individuals who are catastrophically injured in car crashes including bicyclists.

As the statewide organization working to improve life through bicycling, we must reckon with the sad reality that Michigan is not meeting safety goals for our roadways. We have not moved "Toward Zero Deaths" at the rate targeted in our Strategic Highway Safety Plan. As a result, driver skill more than 20 bicyclistsand seriously injure more than 125 more in Michigan crashesead vear:

These crashes are preventable and should be prevented through statewide application of the Safe System Approach. Until that happens we can anticipate more crashes in years to come. Each of these seriously injured people will require significant rehabilitative care to resume the normal activities of their daily lives. Some will never fully recover and require lifelong care to live with dignity.

We ask you to remember these victims asyou consider the bills before you. We believe that the key changes proposed for reimbursement structures, accreditation requirements, and personal caregiver payments will improve their care and their lives, while reducing confusion and stress for victims and their family members. Listice demands no less
